Dear parents and carers,

The aim of this Information Report is to explain how we implement our SEND policy. In other words, we want to show you how SEND support works in our school.

As educational professionals, we are all working towards the ultimate goal of growing independent young people as they prepare for adulthood. All provision and support we provide is working towards achieving the Kent Children and Young People (CYP) Outcomes Framework:

1. What types of SEND does the school provide for?

Our school provides for pupils with the following needs (as outlined in the SEND Code of Practice 2015):

Cognition and Learning

Section 6.30 & 6.31 CoP

Children may have a learning difficulty and struggle to learn new Literacy and Math skills. This may be due to specific difficulties such as dyslexia, dyscalculia, or dysgraphia.

Communication and Interaction

Section 6.28 & 6.29 CoP

Children may struggle with communication and find understanding language difficult. This may be due to specific language difficulties or conditions such as autism.

Sensory and/or Physical needs

Section 6.34 CoP

Where children may have a physical, or sensory, need which affects the way they are able to access the environment of their learning. This could be due to a number of conditions such as visual or hearing impairment or a physical disability.

Social, Emotional and Mental Health

Section 6.32 CoP

Children may have significant difficulties in managing their emotions and may experience highs and lows. Some conditions associated with this include ADHD, depression, anxiety, attachment disorder and many more.

Often you will find that children's needs overlap and are rarely confined to one area of need, which is why it is important to gain a wholistic overview of your child.

2. Which staff will support my child, and what are their key responsibilities?



At Charlton CE Primary School all staff are considered responsible for supporting the needs of pupils with SEND. Our staff are committed to regular, high-quality training to ensure that they have the knowledge and skills to better meet a wide range of pupil needs.

Below outlines key staff who will be supporting your child. *Please note that this list is not exhaustive.*

Our Special Educational Needs Co-ordinator, or SENCO

The named SENCO is Amy Moat. She can be contacted via the school office or senco@charltonprimary.school

They are a qualified teacher and they have fifteen years' experience in this role.

They achieved the National Award in Special Educational Needs Co-ordination in 2011. They also engaged in a range of training in areas relevant to the role of SENCO.

Class/subject teachers

All of our teachers receive in-house SEN training, and are supported by the SENCO to meet the needs of pupils who have SEN.

Staff have received recent training in the TEACCH approach, Language through Colour, ACES and training from the Autism Education Trust and Inclusive Sport.

Teaching assistants (TAs)

We have a team of 11 TAs, including one higher-level teaching assistants (HLTAs) who are trained to deliver SEN provision. We are also fortunate to have a SEN Assistant, a Pastoral Lead and a Play Therapist. The Pastoral Lead is responsible for our Nurture Team and ELSA.

A number of our teaching assistants who are trained to deliver interventions such as Fizzy, Clever Hands, Sensory Circuits, Brick by Brick training and Attention Autism.

In the last academic year, TAs have been trained in Nurture UK, De-escalation training, Intensive Interaction, Attention Autism and Brick by Brick training. There is an extensive list of training last Tas have received.

We also have two therapy dogs, Rosa and Mavis.

External agencies

Sometimes we need extra help to offer our pupils the support that they need. Whenever necessary we will work with external support services to meet the needs of our pupils with SEND and to support their families. These may include:

- > Child and adolescent mental health services (CAMHS)
- **>** Education welfare officers
- > Emotional Wellbeing Team (EWT)
- > Educational psychologists
- > GPs or paediatricians
- > NELFT practitioners
- ➤ Occupational therapists
- ➤ Therapeutic practitioners such as a Play

- Safeguarding services
- > School Liaison Officer
- > School Health
- >SEND Inclusion Advisor
- > Specialist Teacher Service
- > Speech and language therapists
- ➤ Voluntary sector organisations such as Samphire, Oasis, Kooth, Migrant Help and Project Salus







3. What should I do if I think my child has SEND?

	and your child will be added to the school's SEND register. They will receive

4. What happens if the school identifies a need?

The same process is followed if a concern is raised by the school.



All our class teachers are responsible for the monitoring of all pupils who have been identified as having SEND. They also review those who are not making the expected level of progress in their schoolwork or socially. This might include reviewing children's learning in key curriculum areas such as reading, writing and math. It may also include observations or by using questionnaires linked to key developmental areas such as communication and interaction or a child's physical development. Pupil Progress Meetings and PiXL resources are also used to identify children and plan support where needed.


If the teacher notices that a pupil is having difficulties, they try to find out if the pupil has any gaps in their learning. If they can find a gap, the school will provide appropriate support. Pupils who don't have SEND usually make progress quickly once the gap in their learning has been filled.

If the pupil is still finding it difficult to make the expected progress, the teacher will talk to the SENCO, and will contact you to discuss the possibility that your child has SEND, and the school will follow the graduated approach (see previous page).

5. How will the school measure my child's progress?

We will follow the 'graduated approach' to meeting your child's SEND needs.

The graduated approach is a 4-part cycle of assess, plan, do, review.



Assess	If your child is not making the expected level of progress, we will make an assessment to find out what strengths and difficulties your child has. We will ask for you and your child's input, as well as getting help from external professionals where necessary.
Plan	In discussion with you and your child, we will decide what outcomes we are hoping to achieve. We will make a plan of the support we will offer your child to help them meet
	those outcomes. We will make a record of this and share it with you and all relevant school staff.
Do	We will put our plan into practice. The class teacher, with the support of the SENCO, will be responsible for working with your child on a daily basis, and making sure the support we put in place is having the impact we intended.
Review	We will assess how well the support we put in place helped the pupil to meet the outcomes we set. We will use our improved understanding of your child's needs to improve the support we offer; this may mean the Plan, Assess, Do, Review cycle continues.

6. How will I be involved in decisions made about my child's education?

We will provide an annual written report on your child's progress

A member of staff who knows your child well will meet you at least three times a year, to:

- > Set clear outcomes for your child's progress
- > Review progress towards those outcomes
- Discuss the support we will put in place to help your child make that progress
- Identify what we will do, what we will ask you to do, and what we will ask your child to do

The SENCO may also attend these meetings to provide extra support.

We know that you're the expert when it comes to your child's needs and aspirations. So, we want to make sure you have a full understanding of how we're trying to meet your child's needs, so that you can provide insight into what you think would work best for your child.

We also want to hear from you as much as possible so that we can build a better picture of how the SEND support we are providing is impacting your child outside of school.

If your child's needs or aspirations change at any time, please let us know right away so we can keep our provision as relevant as possible.

7. How will my child be involved in decisions made about their education?

The level of involvement will depend on your child's age and individual needs. We recognise that no two pupils are the same, so we will decide on a case-by-case basis, with your input.

We may seek your child's views by asking them to:

- > Attend meetings to discuss their progress and outcomes
- > Prepare a presentation, written statement, video, drawing, etc.
- > Discuss their views with a member of staff who can act as a representative during the meeting
- > Complete a survey



8. How will the school adapt its teaching for my child?

Your child's teacher is responsible and accountable for the progress and development of all the pupils in their class.

High-quality teaching is our first step in responding to your child's needs. We will make sure that your child has access to a broad and balanced curriculum in every year they are at our school.

We will adapt our approaches to how we teach to suit the way the pupil works best. There is no 'one size fits all' approach to adapting the curriculum, we work on a case-by case basis to make sure the adaptations we make are meaningful to your child and are guided by the Mainstream Core Standards in the first instance.

These adaptations may include:



Adapting our approaches, for example, giving longer processing times, pre-teaching of key vocabulary, reading instructions aloud, etc.



> Adapting our resources and staffing



Using recommended aids, such as laptops, coloured overlays, visual timetables, larger font,



>Teaching assistants or support staff will support pupils appropriately depending on their presentation of need



>Scaffolding lesson materials

We may also provide the following interventions:

- Sensory Circuits
- Attention Autism
- Fizzy
- Clever Hands
- Plus 1
- Brick by Brick

- Speech and Language
- ELSA
- Nurture UK

These interventions are part of our contribution to Kent County Council's local offer.

9. How will the school evaluate whether the support in place is helping my child?

We will evaluate the effectiveness of provision for your child by:

- > Reviewing their progress towards their goals each term
- Reviewing the impact of interventions after 6-12 weeks depending on the intervention



- Using pupil questionnaires
- > Using relevant questionnaires and assessments
- Monitoring by the SENCO
- Using provision maps to measure progress
- ➤ Holding an annual review (if they have an education, health and care (EHC) plan)

10. How will the school ensure my child has appropriate resources?

It may be that your child's needs mean we need to provide additional resources such as:

- Additional resources to support their learning
- Adaptations to in class support
- Further training for our staff
- External specialist expertise

Where appropriate, we will consult with external agencies to get recommendations on what will best help your child access their learning and use our best endeavours to ensure these are supplied. If it is deemed appropriate High Needs Funding (HNF) may be sought to further secure interventions and resources for children.

11. How will the school make sure my child is included in activities alongside pupils who don't have SEND?



The expectation is that all schools providing an inclusive provision for all pupils. It may be necessary for some pupils to receive interventions in addition to a broad and balanced curriculum.

All of our extra-curricular activities and school visits are available to all our pupils, including our before and after-school clubs.

All pupils are encouraged to go on our school trips, including our residential trip in year 6.

All pupils are encouraged to take part in sports day, school events such as the Nativity or Harvest Festival and trips such as the Pantomime or other trips linked to the learning in class.

No pupil is ever excluded from taking part in these activities because of their SEN or disability and we will make whatever reasonable adjustments are needed to make sure that they can be included.

12. How does the school make sure the admissions process is fair for pupils with SEN or a disability?

13. How does the school support pupils with disabilities?

You're disabled under the Equality Act 2010 if you have a physical or mental impairment that has a 'substantial' and 'long-term' negative effect on your ability to do normal daily activities.

14. How will the school support my child's mental health and emotional and social development?

We provide support for pupils to progress in their emotional and social development in the following ways:

- > Pupils with SEND are encouraged to be part of the Junior Leadership Team
- > We have two therapy dogs to support the SEMH needs of pupils
- > We provide extra pastoral support for listening to the views of pupils with SEND. We have a Nurture Team and an ELSA
- > We run a nurture lunchtimes and nurture sessions for pupils who need extra support with social or emotional development
- > We work closely with external agencies such as School Health and the Emotional Wellbeing Team (EWT) to provide SEMH support
- > We have a 'zero tolerance' approach to bullying. We prevent bullying in the school. Please see our anti-bullying here: https://www.charlton.kent.sch.uk/policies/

15. What support is in place for looked-after and previously looked-after children with SEND?



Amy Moat, the SENCO is our designated teacher. She will make sure that all teachers understand how a looked-after or previously looked-after pupil's circumstances and their SEND might interact, and what the implications are for teaching and learning.

Pupils who are looked-after or previously looked-after will be supported much in the same way as any other child who has SEND. However, looked-after pupils will also have a personal education plan (PEP). We will make sure that the PEP and any SEND support plans or EHC plans are consistent and complement one another.

16. What support will be available for my child as they transition between classes or settings or in preparing for adulthood?

Between years

To help pupils with SEND be prepared for a new school year we:



- Ask both the current teacher and the next year's teacher to attend the final pupil progress meeting of the year when the pupil's SEND is discussed
- > Schedule time with the incoming teacher and TAs towards the end of the summer

> Provide extra transition support, when required, tailored to the individual needs of pupils with SEND

Between schools

When your child is moving on from our school, we will ask you and your child what information you want us to share with the new setting.

Between phases (Primary to Secondary)

The SENCO of the secondary school will come into our school for a meeting with our SENCO. They will discuss the needs of all the pupils who are receiving SEND support.

Pupils will be prepared for the transition by:

- > Practising with a secondary school timetable
- > Learning how to get organised independently
- > Plugging any gaps in knowledge
- > Attending taster sessions at the secondary school if appropriate



17. What support is available for me and my family?

18. What should I do if I have a complaint about my child's SEND support?

Complaints about SEND provision in our school should be made to the SENCO in the first instance. They will then be referred to the school's complaints policy.

If you are not satisfied with the school's response, you can escalate the complaint. In some circumstances, this right also applies to the pupil themselves.

To see a full explanation of suitable avenues for complaint, see pages 246 and 247 of the <u>SEND Code</u> of <u>Practice</u>.

If you feel that our school discriminated against your child because of their SEND, you have the right to make a discrimination claim to the first-tier SEND tribunal. To find out how to make such a claim, you should visit: https://www.gov.uk/complain-about-school/disability-discrimination

You can make a claim about alleged discrimination regarding:

- Admission
- **>** Exclusion
- > Provision of education and associated services
- Making reasonable adjustments, including the provision of auxiliary aids and services

Before going to a SEND tribunal, you can go through processes called disagreement resolution or mediation, where you try to resolve your disagreement before it reaches the tribunal.

20. Glossary

- ➤ Access arrangements special arrangements to allow pupils with SEND to access assessments or exams
- ➤ Annual review an annual meeting to review the provision in a pupil's EHC plan
- > Area of need the 4 areas of need describe different types of needs a pupil with SEND can have. The 4 areas are communication and interaction; cognition and learning; physical and/or sensory; and social, emotional and mental health needs.
- > CAMHS child and adolescent mental health services
- **▶ Differentiation** when teachers adapt how they teach in response to a pupil's needs
- **EHC needs assessment** the needs assessment is the first step on the way to securing an EHC plan. The local authority will do an assessment to decide whether a child needs an EHC plan.
- ➤ EHC plan an education, health and care plan is a legally-binding document that sets out a child's needs and the provision that will be put in place to meet their needs.
- ➤ First-tier tribunal/SEND tribunal a court where you can appeal against the local authority's decisions about EHC needs assessments or plans and against discrimination by a school or local authority due to SEND
- ➤ Graduated approach an approach to providing SEND support in which the school provides support in successive cycles of assessing the pupil's needs, planning the provision, implementing the plan, and reviewing the impact of the action on the pupil
- ➤ Intervention a short-term, targeted approach to teaching a pupil with a specific outcome in mind
- ➤ Local offer information provided by the local authority which explains what services and support are on offer for pupils with SEND in the local area
- ➤ Outcome target for improvement for pupils with SEND. These targets don't necessarily have to be related to academic attainment
- ➤ Reasonable adjustments changes that the school must make to remove or reduce any disadvantages caused by a child's disability
- > SENCO the special educational needs co-ordinator
- >SEN special educational needs
- > SEND special educational needs and disabilities
- > SEND Code of Practice the statutory guidance that schools must follow to support pupils with SEND
- >SEND information report a report that schools must publish on their website, that explains how the school supports pupils with SEND
- > SEND support special educational provision which meets the needs of pupils with SEND
- > Transition when a pupil moves between years, phases, schools or institutions or life stages
